Establish the right entity, with the right people on the deed.

01

Foreign investment company (PT PMA)

The company a foreign investor uses to do business in Indonesia, with up to 100% foreign ownership depending on the line of business. We handle the deed, the Ministry of Law's approval, the tax and business numbers, and the licences that follow.

02

Local Indonesian company (PT PMDN)

The domestic company for Indonesian shareholders, with no minimum capital set by law. Formed, registered for tax and licensed from start to finish.

03

Individual company (PT Perorangan)

The one-founder company for an Indonesian citizen at micro or small scale, registered electronically with no notary.

04

Representative office

A legal presence for a foreign company to promote, research and coordinate in Indonesia without trading here. Set up and kept compliant.

05

Shelf company

An existing company, for when age or history matters. Availability varies, and each company's record is disclosed before ownership transfers.

06

Local resident shareholder

For sectors where foreign ownership is restricted: what is lawful, how it is documented, and the risks, set out before anything is signed.

07

Resident director

A director resident in Indonesia for your company's deed, drawn from MAM's management, properly appointed and with the limits of the role agreed in writing.

08

Resident commissioner

The supervisory seat every PT must fill, taken by someone who understands the role and appointed with the right documents.

09

Corporate secretary

Registers, shareholder and board resolutions, annual filings and changes to the deed, kept correct and current.

Finance & compliance.

Your books, tax and audit – and the finance leadership above them.

10

Bookkeeping & accounting

Books kept to Indonesian standards and reconciled every month, ready for tax filing and audit, with monthly reports you can act on.

11

Corporate tax & compliance

Monthly and annual filings and withholding tax, run against the compliance calendar so nothing is missed or filed late.

12

Personal tax

Registration, annual returns and advice for expatriates and business owners.

13

External audit

Statutory audit of financial statements, performed by MAM and signed by a licensed public accounting firm (KAP).

14

Internal audit

Reviews of controls, risk and process that find the gaps before someone else does, with findings you can act on.

15

Virtual CFO & business advisory

Senior finance judgement at the hours you need it: budgets, cash flow, forecasts and board reporting.

Payroll

Payroll processed accurately and on time every month, with PPh 21, BPJS and every statutory deduction handled, and an optional online HR portal.

17

Employer of Record (EOR)

Hire and pay staff in Indonesia without setting up a company first. We employ them for you, with contracts, payroll, BPJS and compliance carried by us.

18

HR consulting

Employment agreements and employee handbooks drafted to Indonesian law, first-time BPJS registration of the company and its staff, and ongoing HR advice from our own team.

19

Investor KITAS

The stay permit for shareholders and directors of an Indonesian company, with eligibility checked before the application is made.

20

Work permit KITAS

For your foreign staff: the foreign worker plan (RPTKA), the work visa and the stay permit, handled as one process.

21

Business visa

For meetings, negotiation and site visits, matched to what you are coming to do. Not for work.

22

Tourist, family & social visas

Tourist and visit visas, social visas, and the stay permits spouses, children and other dependants need.

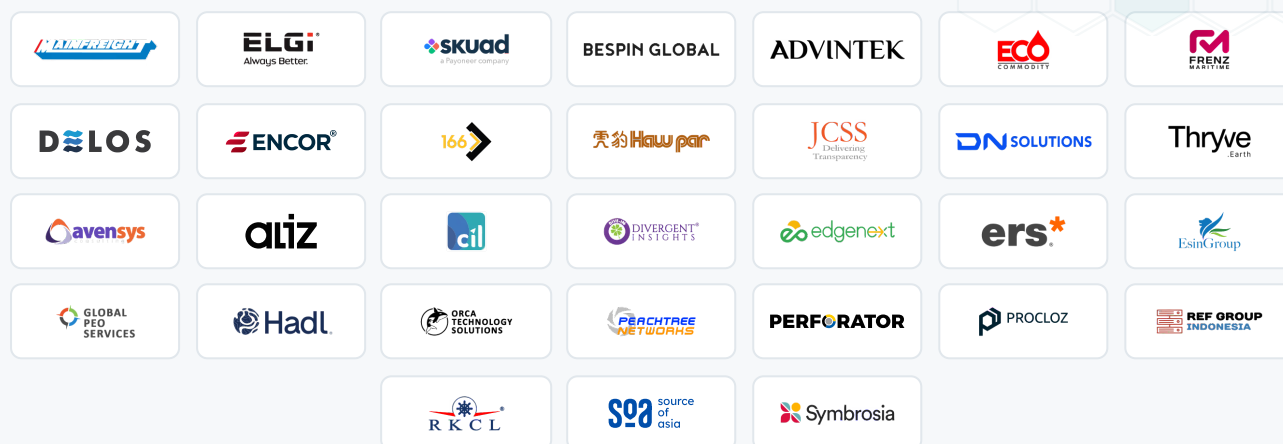
